SAILING INSTRUCTIONS

**The Organising Authority is the Draycote Water Sailing Club
in conjunction with the UK RS Tera Class Association.**

The notation '[NP]' in a rule of the sailing instructions (SIs) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1

The notation '[DP]' in a rule in the SIs means that the penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than a disqualification

1. Rules

- 1.1. The event will be governed by the Racing Rules of Sailing.
- 1.2. Rule 44.1 is changed so that a boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident while racing.
- 1.3. The following documents apply:
 - 1.3.1. The International RS Tera Class Rules apply, available at <https://www.rstera.org.uk/documents>In addition:
 - 1.3.2. All sailors must wear a whistle attached to their buoyancy aids [DP]
 - 1.3.3. All boats shall carry a painter of 6mm floating line at least 8m in length (measured from the fitment point on the boat) [DP]
 - 1.3.4. It is advised that the rear handles on the transom should have the plastic loops fitted as supplied by RS.
 - 1.3.5. The scrutineering process which is intended to assist in compliance with the RS Tera Class Rules will involve boats being selected at random for checks during the event. That technical officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in the rules.
 - 1.3.6. Long hair should be tied back so it does not pose a threat to the sailors's safety.
 - 1.3.7. Draycote Water SC and the UK RS Tera Class Association implement the Royal Yachting Association (RYA) Racing Charter, available at: <https://www.rya.org.uk/racing/rules/racing-charter>
 - 1.3.8. The RYA Arbitration, Advisory Hearing and Post-Race Penalty will be available (see <https://www.rya.org.uk/racing/rules/rules-disputes>)
 - 1.3.9. RRS Appendix T (Arbitration) will apply.
- 1.4. The Post-Race Penalty under RRS 44.3(c) will be 30% of the number of boats in the relevant fleet (rounding 0.5 upwards).
- 1.5. RRS 40.1 will apply at all times whilst afloat.
- 1.6. RRS 63.5(c) is changed so that in the event of a conflict between the Notice of Race and Sailing Instructions, the Sailing Instructions shall prevail.

2. Changes to Sailing Instructions

Any change to the sailing instructions will be posted at least one hour before the first race in which it will take effect, except that any change to the schedule of races will be posted by 20.00 on the day before it will take effect.

3. Communications with Competitors

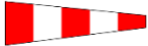
A physical noticeboard is located situated in the clubhouse as a courtesy to competitors.

A WhatsApp group is established for communications with competitors and shall be regarded as the communication channel for the event. The link will be emailed to all competitors prior to the event.

The race office may be contacted on the balcony outside the bar.

4. Signals Made Ashore

4.1. Signals made ashore will be displayed on the signal mast at the front of the clubhouse.

4.2. When flag AP  is flying ashore, 'the warning signal will be made' is replaced with 'Flag D will be raised' in the Race Signals section of the RRS. Any further postponement signals will be made from the committee boat in accordance with the Racing Signals section of the RRS.

4.2.1. [DP] Flag  D with fleet flag and one sound means 'Boats in displayed fleet can launch. Boats shall not launch until this signal is made. The warning signal will not be made before the scheduled time or less than 20 minutes after flag D is displayed'

5. Schedule of Races

5.1. The table below shows the scheduled times for warning signals for each day of the event:

Day	Event	Time
Saturday 18 th October	Registration open	0830 – 1000
Saturday 18 th October	Briefing on the patio	1005
Saturday 18 th October	First warning signal	1110
Sunday 19 th October	First warning signal	0955
Sunday 19 th October	Last possible time for a warning signal	1530
Sunday 19 th October	Prizegiving	As soon as possible after racing

5.2. The Championship will consist of up to 8 races. The intention is that there will be no more than 4 races a day. One extra race per day may be sailed, provided that no fleet becomes more than one race ahead of schedule.

5.3. To alert boats that a race or sequence of races will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before a warning signal is made.

6. Class Flags

The class flag for the RS Tera Pro fleet is a yellow flag with the word 'Pro' in black text.

PRO

The class flag for the RS Tera Sport is a white flag with the word 'Sport' in black text

SPORT

7. Courses

7.1. The diagrams in SI Addendum 1 show the courses to be sailed, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.

7.2. A gate may be replaced by a single mark to be left to port

8. Marks

8.1. All rounding marks shall be orange dumpy race marks.

8.2. The starting mark will be a boat displaying an orange flag or dan buoy with an orange flag.

8.3. The finishing mark will be a dan buoy with a blue flag.

9. Obstructions

9.1. Boats shall not sail at any time within 30 metres of the shore except at the club compound. Landing in an exclusion area is allowed only in an emergency.

9.2. Fishing boats, whether engaged in fishing or not. For this purpose, the area within which a fishing line extends from, or is being cast from a fishing boat, shall form part of the fishing boat.

9.3. Rescue boats and committee boats when not displaying definitive start or finish flags.

9.4. The Section of building site in the vicinity of A and M marked by the Yellow Buoys.

10. The Start

- 10.1. The starting line is between a staff displaying an orange flag on the committee boat and the Starting Mark.
- 10.2. [DP] Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 10.3. A boat that does not start within 4 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2
- 10.4. The PRO fleet will start first, followed by the SPORT fleet.
- 10.5. If there is a general recall  for the PRO fleet, the SPORT fleet will be started after the restart of the PRO fleet.

11. Change of the Next Leg of the Course

- 11.1. To change the next leg of the course, the race committee will move the original mark or the finishing line to a new position.
- 11.2. Minor mark moves of up to 100m or approximately 5 degrees may be made without a signal. This changes RRS 33

12. The Finish

- 12.1. The finishing line will be between a mast displaying a blue flag on the race committee boat and the finishing mark.
- 12.2. Scoring other boats:
 - 12.2.1. After the first boat has sailed the course and finished, the race committee may score other boats based on their relative positions at a mark of the course or on a leg of the course.
 - 12.2.2. When a race committee boat displays flag W, boats still racing may be finished by this race committee boat.
 - 12.2.3. When a boat is scored in accordance with this instruction, she shall be given score for a place after all boats that have sailed the course and finished. This changes RRS 35, A4 and A5.

13. Time Limits and Target Times

- 13.1. The Race Time Limit (see RRS 35), Target Time for the first boat and Finishing Window are show in the table below

Race Time Limit	Target Time	Finishing Window
60 minutes	45 minutes	10 minutes

- 13.2. The Finishing Window is the time for boats to finish after the first boat sails the course and finishes. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized or given redress, will be scored Did not finish (DNF) without a hearing. A boat scored DNF shall be scored points for the finishing place one more than the points scored by the last boat that finished within the Finishing Window. This changes RRS 35, A5.1, A5.2 and A10.
- 13.3. Failure to meet the Target Time will not be grounds for redress. This changes RRS62.1(a)

Hearing Requests

- 13.4. For each class, the protest time limit is 45 minutes after the last boat in that class finishes the last race of the day or the race committee signals no more racing today, whichever is later. The time will be posted on the official noticeboard.
- 13.5. Hearing request forms are available to be completed from the race office or online at <http://draycotewater.co.uk/sailing-events/protest-form/>
- 13.6. Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearing location will be published with the schedule on the official notice board.

14. Replacement of Crew or Equipment

- 14.1. [DP] Substitution of competitors is not allowed without prior written approval of the Race Committee.
- 14.2. [DP] Substitution of damaged or lost equipment is not allowed unless authorized in writing by the Race Committee. Requests for substitution shall be made to the committee at the first reasonable opportunity, which may be after the race.

15. SAFETY REGULATIONS

- 15.1. Competitors shall wear a personal flotation device at all times while afloat, except briefly while adjusting clothing or personal equipment. This changes RRS 40. [DP]
- 15.2. A boat that retires from a race shall notify an official boat as soon as possible. A declaration form is available from the race office which must be completed by competitors when ashore. Competitors may also use this form to indicate races which they did not finish (DNF) or in which they took penalty turns. [DP]

16. Berthing

Please note that berthing is specifically for competitors RS Teras and no other sailing craft can be stored or launched from Draycote Water Sailing Club during the event.

17. Risk Statement

Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any competitors briefing held for the event.

18. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

19. LOCAL INFORMATION

SHALLOWS: Competitors are advised to check the Notice Board for notification of shallows. Shallows are marked with large yellow round buoys.

All entrants and authorised guests will be deemed to be guests of Draycote Water Sailing Club during the period of the open meeting and, as such, will abide by all of the club rules and by-laws and may sail only the boat entered for the open meeting.

All entrants and authorised guests shall also comply with the following Water Authority Regulations. We reserve the right to disqualify any competitor without a hearing any competitor who does not comply with these local rules (this changes RRS 63.1 and A5):

- (a) No parking of vehicles on any roadways, slipways or grass areas. All vehicles shall be parked in the sailing club main car park or Severn Trent pay & display car park once the trailer and boat are unloaded. All competitors must follow the instructions of the marshals during unloading, loading and car parking.
 - (b) Dogs are not allowed on the site. They may be walked in the adjacent Country Park.
 - (c) All competitors must follow the Check, Clean, Dry programme before arriving at Draycote and commit to following it having left Draycote before their next launch.
- All visitors will be required to sign a disclaimer to this effect.

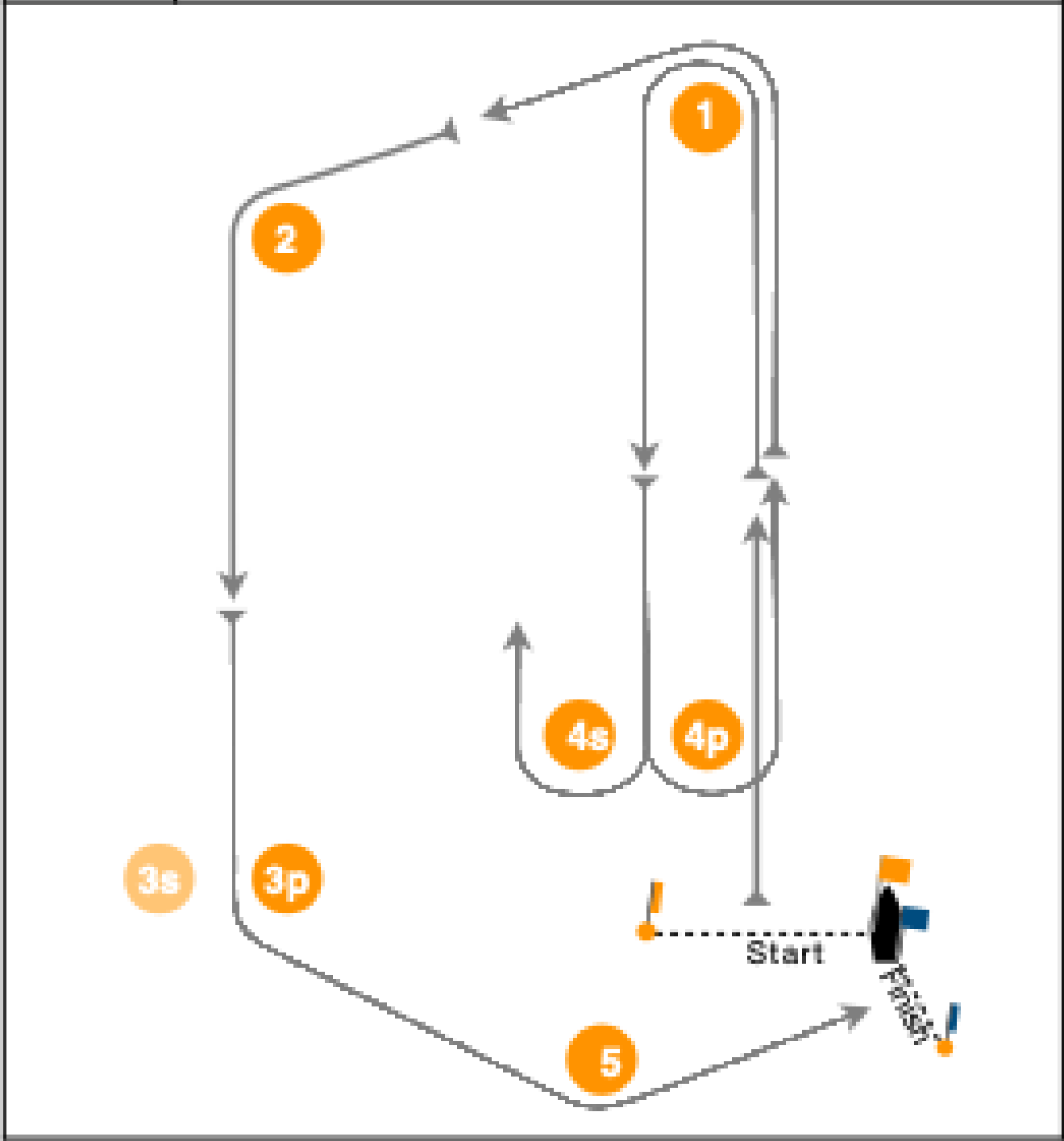

SI ATTACHMENT C

INCIDENTS ON THE WATER - SOME EXPLANATIONS

Protests and Arbitration

If you are involved in an incident on the water - you may want to protest another boat. To do so you must immediately hail 'Protest' at the first reasonable opportunity. Later you can fill in a protest form and deliver it at the race office before the protest time limit ends.

At this event we will be operating a system of Arbitration. This is set out in RRS Appendix T.

Advisory hearing

If you have been involved in an incident - but you don't want to protest anybody, maybe you want to learn what the rules are in that situation anyway..., then you can ask for an advisory hearing.

This can be a good way to learn more about situations that happen on the water - and nobody will get disqualified or penalised.

If you are told in an advisory hearing that you did break a rule in the situation - you can take a Post Race Penalty or retire - but you don't have to.

RYA Racing Charter

Applies equally to everyone involved in sailboat racing

Principles



Fair Racing

Competitors agree to race fairly; organisers and officials agree to provide fair racing; support persons agree to encourage fair racing and uphold the principles of this Charter.

Fair Resolution

Disputes will be addressed in a timely and proper manner by those responsible; parties involved will use established tools for achieving a fair resolution.



Foul, abusive, aggressive and discriminatory language or behaviour, or a lack of respect for others and their property, will not be tolerated.

Respect



Those who take unfair advantage of sailing's self-policing nature, or behave inappropriately, can expect action to be taken against them.
