SAILING INSTRUCTIONS

The Organising Authority is Burton Sailing Club in conjunction with the UK RS Tera Class Association.

The notation '[NP]' in a rule of the sailing instructions (SIs) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

The notation '[DP]' in a rule in the SIs means that the penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than a disqualification

1. Rules

- 1.1. The event will be governed by the Racing Rules of Sailing.
- 1.2. Rule 44.1 is changed so that a boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident while racing.
- 1.3. The following documents apply:
 - 1.3.1. The International RS Tera Class Rules, available at https://www.rstera.org.uk/documents
 - 1.3.2. All sailors must wear a whistle attached to their buoyancy aids [DP]
 - 1.3.3. All boats shall carry a painter of 6mm floating line at least 8m in length (measured from the fitment point on the boat) [DP]
 - 1.3.4. It is advised that the rear handles on the transom have the plastic loops fitted as supplied by RS.
 - 1.3.5. The scrutineering process which is intended to assist in compliance with the RS Tera Class Rules could involve boats being selected at random for checks during the event. That technical officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in the rules.
 - 1.3.6. Long hair must be tied back so it does not pose a threat to the sailor's safety.
 - 1.3.7. Burton SC and the UK RS Tera Class Association implement the Royal Yachting Association (RYA) Racing Charter, available at: https://www.rya.org.uk/racing/rules/racing-charter and set out in Addendum 3
 - 1.3.8. RRS Appendix T (Arbitration) will apply
- 1.4. RRS 40.1 will apply at all times whilst afloat.
- 1.5. RRS 63.5(c) is changed so that in the event of a conflict between the Notice of Race and Sailing Instructions, the Sailing Instructions shall prevail.

2. Changes to Sailing Instructions

2.1. Any change to the sailing instructions will be posted at least one hour before the first race in which it will take effect, except that any change to the schedule of races will be posted by 20.00 on the day before it will take effect.

3. Communications with Competitors

- 3.1. The official noticeboard for the event is on the Class Association website at https://www.rstera.org.uk/inlands-2025-noticeboard and information will be posted on the noticeboard outside the Clubhouse.
- 3.2. A WhatsApp group is established for communications with competitors and shall be regarded as the communication channel for the event.

- 3.3. From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all hoats
- 3.4. The race office maybe contacted in the Clubhouse/registration area.

4. Signals Made Ashore

- 4.1. Signals made ashore will be displayed on the signal mast at the front of the Clubhouse.
- 4.2. When flag AP is displayed ashore, "the warning signal will be made" is replaced with "Flag D will be raised" in the Race Signals section of the RRS. Any further postponement signals will be made from the committee boat in accordance with the Racing Signals section of the RRS.
- 4.3. [DP] Green Flag with one sound means one sound means 'Boats in displayed fleet can launch'. Boats shall not launch until this signal is made. The warning signal will not be made before the scheduled time or less than 10 minutes after the green flag D is displayed

5. Schedule of Races

5.1. The table below shows the scheduled times for warning signals for each day of the event:

Day	Event	Time
Friday 27 th June	Boat arrival	From 1430
Friday 27 th June	Registration open	1800 - 2030
Saturday 28 th June	Registration open	0830 to 1000
Saturday 28 th June	Briefing in front of the clubhouse	1010
Saturday 28 th June	First warning signal	10.55 for the RS Tera Pro fleet, 11.01 for the RS Tera Sport fleet
Sunday 29 th June	First warning signal	09.55 for the RS Tera Pro fleet, 10.01 for the RS Tera Sport fleet
Sunday 29 th June	Last possible time for a warning signal	1500 both fleets
Sunday 29 th June	Prizegiving	As soon as possible after racing

- 5.2. The Championship will consist of up to 8 races. The intention is that there will be no more than 4 races a day. One extra race per day may be sailed, provided that no fleet becomes more than one race ahead of schedule. Races may be sailed back-to-back, without coming ashore.
- 5.3. To alert boats that a race or sequence of races will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before a warning signal is made.
- 5.4. There will be an interval of at least one minute between any Start and the Warning Signal for a subsequent Start.

6. Class Flags

6.1. The class flag for the RS Tera Pro fleet is a yellow flag with the word 'Pro' in black text.

PRO SPORT

6.2. The class flag for the RS Tera Sport is a white flag with the word 'Sport' in black text

8. Courses

- 8.1. The diagrams in SI Addendum 1 show the courses to be sailed, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left. The course to be sailed by a fleet will be displayed on the Starboard side of the Committee Boat from no later than the warning signal until at least the starting signal for that fleet
- 8.2. A gate may be replaced by a single mark to be left to port

9. Marks

- 9.1. Marks will be orange long cylindrical inflatable marks
- 9.2. The Starting Mark will be a danbuoy with an orange flag or a race committee vessel displaying an orange flag.
- 9.3. The Finishing Mark will be a danbuoy with a blue flag or a race committee vessel displaying a blue flag.

10. Obstructions

The following areas are designated as obstructions: Water tower adjacent to dam.

11. The Start

- 11.1. Races will be started using RRS 26
- 11.2. The starting line will be between a staff displaying an orange flag on the Committee Boat and the Starting Mark as defined in SI 9.2
- 11.3. [DP] Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 11.4. A boat that does not start within 5 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2
- 11.5. In the main fleets, the PRO fleet will start first, followed by the SPORT fleet. Note however that the Race Officer does have discretion to change the order of starts
- 11.6. If there is a general recall starts will remain in the same sequence eg if the PRO fleet starting first has a general recall,, the SPORT fleet will be started after the restart of the PRO fleet..

12. Change of the Next Leg of the Course

- 12.1. To change the next leg of the course, the race committee will move the original mark or the finishing line to a new position.
- 12.2. Minor mark moves of up to 100m or approximately 5 degrees may be made without a signal. This changes RRS 33

13. The Finish

- 13.1. The finishing line will be between the Committee boat with a blue flag on a staff to port and a danbuoy with a blue flag to starboard
- 13.2. Scoring other boats:
 - 13.2.1. After the first boat has sailed the course and finished, the race committee may score other boats based on their relative positions at a mark of the course or on a leg of the course.
 - 13.2.2. When a race committee boat displays flag W with two sounds, boats still racing may be finished by this race committee boat.
 - 13.2.3. When a boat is scored in accordance with this instruction, she shall be given score for a place after all boats that have sailed the course and finished. This changes RRS 35, A4 and A5.

14. Time Limits and Target Times

14.1. The Race Time Limit (see RRS 35), Target Time for the first boat and Finishing Window are show in the table below

Race Time Limit	Target Time	Finishing Window
60 minutes	45 minutes	15 minutes

14.2. The Finishing Window is the time for boats to finish after the first boat in that fleet sails the course and finishes. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized or given redress, will be scored Did not finish (DNF) without a hearing. A boat scored DNF shall be scored points for the finishing place one more than the points scored by the last boat that finished within the Finishing Window. This changes RRS 35, A5.1, A5.2 and A10.

14.3. Failure to meet the Target Time will not be considered an improper action of the Race Committee under Rule 61.4 (b)(1).

15. Scoring:

- 15.1. The Low Point System of Appendix A will apply.
- 15.2. One race is required to be completed to constitute a series.
- 15.3. The Sport and Pro fleets will be scored separately.
- 15.4. The total score for each boat will be the sum of her scores as follows:
- 15.5. When 3 or fewer races have been completed, a boat's series score will be the total of her race scores;
- 15.6. When from 4 to 6 races have been completed, a boat's series score will be the total of her race scores excluding her worst score;
- 15.7. When 7 races have been completed, a boat's series score will be the total of her race scores excluding her 2 worst scores.

16. Hearing Requests

- 16.1. For each class, the protest time limit is 45 minutes after the last boat in that class finishes the last race of the day or the race committee signals no more racing today, whichever is later. The time will be posted on the official noticeboard.
- 16.2. Hearing request forms are available to be completed from the race office.
- 16.3. Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearing location will be published with the schedule on the official notice board.

17. Replacement of Crew or Equipment

- 17.1. [DP] Substitution of competitors is not allowed without prior written approval of the Race Committee.
- 17.2. [DP] Substitution of damaged or lost equipment is not allowed unless authorized in writing by the Race Committee. Requests for substitution shall be made to the committee at the first reasonable opportunity, which may be after the race.

18. SAFETY REGULATIONS

- 18.1. Competitors shall wear a personal flotation device at all times while afloat, except briefly while adjusting clothing or personal equipment. This changes RRS 40. [DP]
- 18.2. A boat that retires from a race shall notify an official boat as soon as possible. A declaration form is available from the race office which must be completed by competitors when ashore. Competitors may also use this form to indicate races which they did not finish (DNF) or in which they took penalty turns. [DP]

19. Berthing

DP] Boats shall be kept in their assigned places while in the boat park. Competitors and support persons shall comply with reasonable requests from the Association Beach Team marshals. These marshals will be wearing high-viz vests.

20. Risk Statement

Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;

g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any competitors briefing held for the event.

21. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

22. ADDITIONAL NOTES

The Rooster RS Tera Inland Championships 2025 is a selector event for the UKRSTCA RS Tera Performance Academy 2025/26.

Please note that due to the dry conditions in the area, barbeques and fire pits are not permitted anywhere on the club grounds, including camping areas and car parks.





SI ADDENDUM 2

INCIDENTS ON THE WATER - SOME EXPLANATIONS

Protests and Arbitration

If you are involved in an incident on the water - you may want to protest another boat. To do so you must immediately hail 'Protest' at the first reasonable opportunity. Later you can fill in a protest form and deliver it at the race office before the protest time limit ends.

At this event we will be operating a system of Arbitration. This is set out in RRS Appendix T.

Advisory hearing

If you have been involved in an incident - but you don't want to protest anybody, maybe you want to learn what the rules are in that situation anyway..., then you can ask for an advisory hearing.

This can be a good way to learn more about situations that happen on the water - and nobody will get disqualified or penalised.

If you are told in an advisory hearing that you did break a rule in the situation - you can take a Post Race Penalty or retire - but you don't have to.

Racing Charter

Applies equally to everyone involved in sailboat racing

Principles

Fair Racing

Competitors agree to race fairly; organisers and officials agree to provide fair racing; support persons agree to encourage fair racing and uphold the principles of this Charter.

Foul, abusive, aggressive and discriminatory language or behaviour, or a lack of respect for others and their property, will not be tolerated.

Respect

Fair Resolution

Disputes will be addressed in a timely and proper manner by those responsible; parties involved will use established tools for achieving a fair resolution.

Those who take unfair advantage of sailing's self-policing nature, or behave inappropriately, can expect action to be taken against them.
